Summary of Our SEND Offer

1. We identify children's needs early:

Through high-quality teaching, ongoing assessment, and close communication with parents, we quickly identify any child who may need additional support and begin the graduated approach (assess–plan–do–review).

2. We provide tailored support to meet individual needs:

Our provision includes targeted interventions, adapted teaching, specialist resources, and access to a Federation Speech & Language Therapist, ensuring support is personalised and effective.

3. We work in partnership with families:

Parents are involved at every stage. We meet at least three times per year to review progress, agree outcomes, and plan next steps. Child voice is central to all decisions.

4. We work closely with external professionals:

Where needed, we collaborate with Educational Psychologists, Advisory Teaching Service, NHS therapists, and other agencies to ensure children receive specialist, evidence-based support.

5. We ensure full inclusion in all aspects of school life:

All pupils with SEND are encouraged and supported to take part in trips, clubs, activities, leadership roles, and wider school opportunities, with risk assessments and reasonable adjustments in place.

6. We support emotional wellbeing and positive relationships:

Using Thrive, restorative practice, our Wellbeing and Inclusion Team (WAIT), and trauma-informed approaches, we prioritise pupils' social and emotional development alongside academic needs.

1. Aims

Our SEND policy and information report is designed to:

- Outline how our Federation supports and provides for pupils with Special Educational Needs and Disabilities (SEND)
- Clarify the roles and responsibilities of all those involved in delivering SEND provision
- Ensure that all pupils can access and participate fully in every aspect of Federation life
- Recognise that special educational provision refers to additional or different support beyond what is typically provided for children of the same age in mainstream schools
- Foster an inclusive environment that offers opportunities for success to every child
- Make learning accessible for all, regardless of learning style, gender, ability, medical needs, disability, family circumstances, ethnicity, language, or cultural background

2. Legislation and guidance

This policy and information report is based on the statutory [Special Educational Needs and Disability \(SEND\) Code of Practice](#) and the following legislation:

- [Part 3 of the Children and Families Act 2014](#), which sets out Federations' responsibilities for pupils with SEND and disabilities
- [The Special Educational Needs and Disability Regulations 2014](#), which set out school's responsibilities for education, health and care (EHC) plans, SEND Co-ordinators (SENDCos) and the SEND information report. This policy also complies with our funding agreement and articles of association. In accordance with the Equality Act 2010, the Federation fulfils its anticipatory duty by planning ahead to remove barriers for current and future disabled pupils and by making reasonable adjustments, including auxiliary aids and services, to prevent substantial disadvantage. The Federation ensures that pupils with disabilities are not treated less favourably than their peers.
- We take an anticipatory approach to accessibility, planning ahead to remove barriers for current and future pupils with disabilities

3. Definitions

A child has SEND if they have a learning difficulty or disability which calls for special educational provision to be made for them.

They have a learning difficulty or disability if they have:

- A significantly greater difficulty in learning than the majority of others of the same age, or
- A disability which prevents or hinders them from making use of facilities of a kind generally provided for others of the same age in mainstream school

Special educational provision is educational or training provision that is additional to, or different from, that made generally for other children or young people of the same age by mainstream schools.

4. Roles and responsibilities

4.1 The SENDCo

The SENDCo will:

- Work with the Executive Head of Federation and SEND Governor to determine the strategic development of the SEND policy and provision in the Federation
- Have day-to-day responsibility for the operation of this SEND policy and the co-ordination of specific provision made to support individual pupils with SEND, including those who have EHC plans
- Provide professional guidance to colleagues and work with staff, parents, and other agencies to ensure that pupils with SEND receive appropriate support and high-quality teaching
- Advise on the graduated approach to providing SEND support
- Advise on the deployment of the Federation's delegated budget and other resources to meet pupils' needs effectively

- Be the point of contact for external agencies, especially the local authority and its support services
- Liaise with potential next providers of education to ensure pupils and their parents are informed about options and a smooth transition is planned
- Work with the Executive Head of Federation and Federation Governors to ensure that the Federation meets its responsibilities under the Equality Act 2010, including preventing less favourable treatment and ensuring reasonable adjustments and access arrangements
- Ensure the Federation keeps the records of all pupils with SEND up to date
- Act as the Designated Teacher for Children Looked After with strategic responsibility for the inclusion of those who are adopted or in local authority care
- Support subject leads to make the curriculum accessible to children

4.2 The SEND Governor

The SEND Governor will:

- Help to raise awareness of SEND issues at Governor meetings
- Monitor the quality and effectiveness of SEND and disability provision within the Federation and update the Governors on this
- Work with the Executive Head and SENDCo to determine the strategic development of the SEND policy and provision in the Federation

4.3 The Executive Head of the Federation

The Head of Federation will:

- Work with the SENDCo, SEND Governor and executive leadership team to determine the strategic development of the SEND policy and provision in the Federation
- Have overall responsibility for the provision and progress of learners with SEN and/or a disability

4.4 Class teachers

Each class teacher is responsible for:

- The progress and development of every child in their class
- Working closely with any teaching assistants or specialist staff to plan and assess the impact of support and interventions and how they can be linked to classroom teaching
- Working with the SENDCo to review each pupil's progress and development and decide on any changes to provision
- Ensuring that children have a My Plan/My Plan+ with SMART targets. They will ensure that it is reviewed according to the cycle and that the outcomes are constantly tracked and updated as appropriate.
- Ensuring they follow this SEND policy

4.5 Subject Leads

Each subject lead is responsible for:

- Sign posting class teachers to suitable resources for SEND in their curriculum
- Leading in house CPD for adaptation in order ensure that all children can access each curriculum area
- Monitoring impact in their subject area for all children with the SENDCo and the Executive Leadership Team

5. SEND information report

5.1 The kinds of SEND that are provided for:

Our Federation currently provides additional and/or different provision for a range of needs, including:

- Communication and interaction, for example, autistic spectrum disorder, Asperger's Syndrome, speech and language difficulties
- Cognition and learning, for example, dyslexia, dyspraxia,
- Social, emotional and mental health difficulties, for example, attention deficit hyperactivity disorder (ADHD),
- Sensory and/or physical needs, for example, visual impairments, hearing impairments, processing difficulties, epilepsy

5.1a Admissions for Pupils with SEND

As a maintained school, we follow the statutory School Admissions Code. The Federation does not refuse admission to a pupil with SEND and will not discriminate on the basis of SEND. Pupils with an EHCP naming the school will be admitted, and reasonable adjustments will be made where required.

5.2 Identifying pupils with SEND and assessing their needs

We assess each pupil's skills and attainment levels upon entry, building on previous settings and key stage data where applicable. Through continuous monitoring and assessment, we swiftly identify children who may require additional support beyond high-quality first teaching.

If concerns arise, teachers consult with the Special Educational Needs & Disabilities Coordinator (SENDCo) for further assessment. This process may involve observations, discussions with the child, specific assessments in reading, writing, or maths, and conversations with parents. Where necessary, we seek specialist advice to support both the school and families. If appropriate, we will make referrals for statutory assessments in collaboration with parents and carers.

Children may require additional support for various reasons, including:

- Social, emotional, or behavioural challenges
- Difficulty keeping up with peers or national expectations
- Slower than expected progress
- Lack of improvement despite interventions
- Not reaching their full potential

We recognise that progress extends beyond academic attainment and includes social and emotional development. However, slow progress or low attainment alone does not automatically indicate SEND.

When determining the need for special educational provision, we begin by identifying desired outcomes, including expected progress and attainment, alongside the views of the child and their parents. Based on this, we determine the necessary support—whether it can be provided through adaptations to our core offer or if additional interventions are required. Teachers complete the Quality First Teaching checklist to document the strategies and support already implemented.

5.3 Consulting and involving pupils and parents

We will have an early discussion with the child and their parents when identifying whether they need special educational provision. These conversations will make sure that:

- Everyone develops a good understanding of the pupil's areas of strength and difficulty
- We take into account the parents' concerns
- The child is at the heart of discussions and that their views are heard
- Everyone understands the agreed outcomes sought for the child
- Everyone is clear on what the next steps are

We will notify parents when it is decided that a child will receive SEND support.

5.4 Assessing and reviewing pupils' progress towards outcomes

We follow the graduated approach and the four-part cycle of **assess, plan, do, review**.

Class teachers are responsible for drawing up a plan for a child who has any additional support whether that be at an additional support, My Plan, My Plan+ or EHCP level.

The class teacher is responsible for the writing of SMART targets on the plan and ensuring that all the interventions are tracked and logged on the class provision map. They are responsible for reviewing and writing new targets.

The class teacher will work with the SENDCo to carry out a clear analysis of the pupil's needs. This will draw on:

- The teacher's assessment and experience of the child
- Their previous progress and attainment and behaviour
- Other teachers' assessments, where relevant
- The individual's development in comparison to their peers and national data
- The views and experience of parents
- The pupil's own views
- Advice from external support services, if relevant

All teachers and support staff who work with the child will be made aware of their needs, the outcomes sought, the support provided, and any teaching strategies or approaches that are required. We closely track the progress of children on Provision Map and INSIGHT to ensure that progress is being made and that the provision is meeting the child's needs. We will regularly review the effectiveness of the support and interventions and their impact on the pupil's progress on their Provision Map.

Additional Support Plans, My Plans and IEP's, (Individual Education Plans), are reviewed 3x per year Oct, Feb and May. Teachers meet with parents after the review to share the new plan and log the meeting on CPOM's, (Child Protection Online Management System).

My Plan+'s are reviewed every 6-8 weeks and teachers share with parents and log on CPOM's.

5.5 Supporting pupils moving between phases

When your child joins us, we endeavour to gather as much information as possible through discussions with parents, previous settings, and any services that may have been involved in their care.

As part of the transition into the Federation, staff will communicate with all pre-Federation providers to share relevant information about the children joining us. Reception teachers and/or the SENDCo will visit pre-Federation settings to gain valuable insights, ensuring a smooth and successful transition. Where specific needs are identified, we will take proactive steps such as pre-training staff, visiting other settings to meet staff and children, and seeking expert advice on how best to support your child.

When children move on to a new setting, we ensure that all relevant information is shared with the appropriate staff. We continue to strengthen our links with local secondary schools to facilitate a smooth transition for pupils moving into Year 7. Thorough handover meetings with feeder secondary schools enable us to provide key information, and additional transition visits can be arranged for those requiring extra support.

5.6 Our approach to teaching pupils with SEND

Teachers are responsible and accountable for the progress and development of all the pupils in their class.

High Quality First Teaching is our first step in responding to pupils who have SEND and part of our good practice in making teaching and learning accessible to pupils learning at different rates. Quality First Teaching is a style of teaching that emphasises high quality, inclusive teaching for all pupils in a class. QFT includes adaptive learning, strategies to support SEN pupils' learning in class, on-going formative assessment and many others.

The Executive Leadership Team (Executive Headteacher, Federation Deputy Headteacher, SENDCo, Federation Assistant Head) and relevant middle leaders carry out regular monitoring and work scrutiny to ensure individual needs are being met.

We will also provide a selection of the following intervention:

- Literacy Gold – a reading, comprehension and spelling online program
- Fizzy - gross and fine motor intervention

- Jimbo Fun - fine motor intervention/handwriting intervention
- Write from the Start – handwriting intervention
- Thrive – a trauma-informed, whole school or setting approach that helps to improve the mental health and wellbeing of children and young people
- Sensory Circuits
- Numicon breaking barriers – Maths program
- Essential Letters and Sounds – Phonics program
- Speech and Language interventions
- Clicker 8 - software used to enable pupils with literacy and/or physical difficulties to access all areas of the curriculum
- Typing Club – touch typing program
- Widgit – visuals support

5.7 Adaptations to the curriculum and learning environment

We make the following adaptations and reasonable adjustments to the curriculum and/or learning environment to ensure all pupils' needs are met:

- Adapting our teaching to ensure all pupils can access it, for example, use of manipulatives, adaptations to recording of information, use of visuals
- Adapting our resources and staffing
- Using recommended aids, such as laptops, coloured overlays, visual timetables, larger font, etc.
- Adapting and scaffolding our teaching, for example, giving longer processing times, pre-teaching of key vocabulary, reading instructions aloud, etc.
- In considering what adaptations we need to make, the SENDCo works with the other members of the Senior Leadership Team and Governors to ensure that the Federation meets its responsibilities under the Equality Act (2010) regarding reasonable adjustments and access arrangements.

5.8 Additional support for learning

Within Federation, we have:

- Federation Speech and Language Therapist
- 1:1 or small group interventions based on need
- Teaching Assistants trained in specific areas to support children with SEND
- Teaching Assistants trained to support learning in our classes
- Work set at appropriate levels through the planning process.
- A range of pastoral support in place led by the Wellbeing And Inclusion Team (WAIT)

We work with the following outside agencies:

- Educational Psychologist
- Advisory Teaching Service
- Local Authority Casework Team
- NHS Speech and Language Therapy
- Occupational Therapy
- Physiotherapy
- School Nurses
- Consultant Paediatrician
- GP
- Children's Services
- Families First

5.9 Expertise and training of staff

All staff receive training to effectively support all learners and maximise their achievement, as part of the Federation's development plan and annual schedule of continuous professional development. Specific training needs are identified and addressed through the appraisal and performance management process.

The SENDCo holds the mandatory National Accreditation for Special Educational Needs Co-ordinators and attends regular SENDCo cluster meetings led by the Local Authority.

The Federation also benefits from a qualified Speech and Language Therapist who works across the schools to assess children, set targets, and train staff.

All staffing appointments to support learners are conducted in line with equal opportunities legislation, employment law, the safer recruitment policy, and best practice. To ensure we employ staff of the highest calibre, all vacancies are competitively advertised.

Ongoing staff training is delivered by the SENDCo and, where appropriate, external agencies such as Occupational Therapists, Educational Psychologists, Speech and Language Therapists, ATS (Advisory Teaching Service) and KCA (Kate Cairns Association, experts in trauma).

5.10 Securing equipment and facilities

We allocate support according to need. Additional interventions are funded to support children's progress. If your child has an Education, Health & Care Plan (EHCP), we will ensure the provision specified in section F is provided as appropriate. We make every reasonable adjustment possible for our children and very much tailor our approach depending on areas of need that arise. We have a fully accessible building that allows full access to all areas of the site.

5.11 Evaluating the effectiveness of SEND provision

We evaluate the effectiveness of provision for pupils with SEND by:

- Reviewing pupils' individual progress towards their targets 3x per year
- Reviewing the impact of interventions
- Using child voice
- Monitoring by the SENDCo
- Using Provision Mapper, My Plans and My Plan+ to set targets and measure progress
- Holding annual reviews for pupils with EHC plans

5.12 Enabling pupils with SEND to engage in activities available to those in the Federation who do not have SEND

We actively encourage our children to participate fully in the broader life of the Federation. All children are given the opportunity to take part in leisure and cultural activities and educational visits. The only exception would occur if a child had breached Federation rules or impacted on the safety of others.

We make every effort to include all children in Federation trips. If an individual risk assessment is required, we will write this in order to ensure that everyone can participate fully. We also prepare all children for any changes in their school day, such as outside visitors, trips and different activities.

At Stonehouse Park Federation, we want all our children to be as successful as they can be in all aspects of life. We want to see all of them achieve well, enjoy social times and demonstrate a positive attitude towards their learning and play.

We have four key PARK values that underpin everything we do.

- Perseverance
- Aspiration
- Respect
- Kindness

Everyone is expected to always take on board these values.

5.13 Support for improving emotional and social development

As a Federation we are developing a restorative approach to encourage pupils to think about how their behaviours affect others, both staff and pupils. This helps children to develop respect, responsibility and honesty.

If a child in our Federation has been negatively affected by someone's behaviour, we will try our very best to make sure they feel that it has been put right for them and that it will not happen again.

If a child has done something wrong, they will be asked to put things right and change their behaviour, so it does not happen again. All children are supported in a constructive way to face up to consequences which will be put in place as a result of the behaviours which have taken place.

By using the Restorative Approach, it allows ALL parties to have their say AND be listened to. Where appropriate visuals will be used to support these conversations. We believe that by using this approach, we are giving pupils the skills to independently repair and restore relationships and encourage children to make better choices in the future.

We are cultivating a nurturing approach across our Federation. All members of the Federation have had training in Thrive, Emotional Literacy, Trauma Informed approach and Adverse Childhood Experiences. All staff have had training in understanding that behaviour is communication. A range of support and resources are in place to support children emotionally.

5.14 Working with other agencies

Our Federation will identify sources of support as part of the Local Offer. This is defined through Education, Health and Social Care (including the establishment of joint commissioning arrangements).

We seek to respond quickly to emerging need and work closely with other agencies including:

- Gloucestershire Early Help Partnership
- Children and Young People Gloucestershire (CYPS)
- Educational Psychology Service
- SENDIASS Gloucestershire (Special Educational Needs and Disability Information, Advice and Support Service)
- Advisory Teaching Service
- Outreach Teams
- Local NHS services, including but not limited to School Nursing, Speech and Language Therapy, Occupational Therapy, Physiotherapy, etc.
- Virtual School (for Looked After Children)
- Education Inclusion Service
- Early Years SEN Support Service
- Multi-Agency Safeguarding Hub

In accordance with the SEND Code of practice 2014, we invite all relevant agencies to annual review meetings, transition meetings and specific provision planning meetings involving pupils with SEND in our federation. For pupils with Education, Health and Care Plans, we comply fully with requests from independent facilitators to provide information and cooperate fully with other agencies.

Often at the request of families, we liaise with voluntary bodies in order to be as familiar as possible with best practice when the special educational needs of a child are very specific (e.g., autism, visual impairment etc).

We have a clear point of contact within the federation who coordinates the support from outside agencies for each pupil. Most often this will be SENDCo/Designated Teacher for LAC, but in some cases, it can be another member of staff who we have identified as a key worker.

5.15 Complaints about SEND provision

If you have a concern or complaint with any aspect of your child's SEND provision, please contact your child's class teacher in the first instance. If your concerns are not addressed, please consult the SENDCo so that we can try to resolve the issue. If your concerns are still not addressed, please contact the Executive Headteacher. The parents of pupils with disabilities have the right to make disability discrimination claims to the first-tier SEND tribunal if they believe that our federation has discriminated against their children. They can make a claim about alleged discrimination regarding:

- Exclusions
- Provision of education and associated services
- Making reasonable adjustments, including the provision of auxiliary aids and services
